### REGIONAL DISTRICT OF CENTRAL OKANAGAN

#### **BYLAW NO. 1254**

A bylaw to establish a service for the purpose of providing for the design, construction, and continued operation of a water distribution system for the Upper Fintry, Shalal Road, and Valley of the Sun communities which is a portion of the Central Okanagan West Electoral Area.

WHEREAS a regional district may, by bylaw, establish a service under the provisions of Part 24 of the Local Government Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a service for the purpose of providing for the design, construction, and continued operation of a water distribution system for the Upper Fintry, Shalal Road, and Valley of the Sun communities which is a portion of the Central Okanagan West Electoral Area;

AND WHEREAS in accordance with Section 797.4 of the Local Government Act, the Regional District has received a valid petition for the service;

AND WHEREAS the Director of the Central Okanagan West Electoral Area has consented to the establishment of the service area;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

- 1. The Regional District hereby establishes within the Central Okanagan West Electoral Area a service for the purpose of providing for the design and construction then continued operation of a water distribution system for the Upper Fintry, Shalal Road, and Valley of the Sun communities, to be known as the "Upper Fintry, Shalal Road, and Valley of the Sun Water Service Area".
- 2. The participants in the service area, established under Section 1, are a portion of the Central Okanagan West Electoral Area.
- 3. The boundaries of the service area are shown outlined on Schedule "A" attached hereto and forming part of this bylaw.
- 4. The annual costs for the service established in Section 1 shall be recovered by:
  - a) The requisition of money under Section 806 to be collected by a parcel tax imposed in the manner provided by Section 806.1, and
  - b) The imposition of fees and other charges that may be set by separate bylaw for the purpose of recovering these costs.
- 5. The maximum amount that may be requisitioned under Section 806 for the service shall be \$435,000.00.
- 6. The Regional Board may, by separate bylaw, provide that the parcel tax imposition under Section 806.1(1)(b) may be commuted for payment in cash under the terms and conditions set under that bylaw.

7. This bylaw may be cited as the "Regional District of Central Okanagan Upper Fintry, Shalal Road, and Valley of the Sun Water Service Area Establishment Bylaw No. 1254, 2009".


